BLOCK ZERO PRESENTATION ENGINE SOFTWARE DEVELOPMENT AND PLATFORM

These license terms are an agreement between you and Block Zero AB (or one of its affiliates). They apply to the software named above and any Block Zero services or software updates (except to the extent such services or updates are accompanied by new or additional terms, in which case those different terms apply prospectively and do not alter your or Block Zero's rights relating to pre-updated software or services). IF YOU COMPLY WITH THESE LICENSE TERMS, YOU HAVE THE RIGHTS BELOW.

The terms were updated 2023 October 19.

1. LICENSE

- Under this Agreement, Block Zero AB (the "Vendor") grants to the Licensee a non-exclusive and non-transferable license (the "License") to use Presentation Engine (the "Software").
- Software includes the executable computer programs, libraries and any related printed, electronic and online documentation and any other files that may accompany the product.
- Title, copyright, intellectual property rights, and distribution rights of the Software remain exclusively with the Vendor. Intellectual property rights include the look and feel of the Software. This Agreement constitutes a license for use only and is not in any way a transfer of ownership rights to the Software.
- The term of this Agreement will begin on Acceptance and is perpetual. Usage of the Software in any form is regarded as Accepting these terms.
- The rights and obligations of this Agreement are personal rights granted to the Licensee only. The
 Licensee may not transfer or assign any of the rights or obligations granted under this Agreement to
 any other person or legal entity. The Licensee may not make available the Software for use by one or
 more third parties.
- The Software may not be modified, reverse-engineered, or de-compiled in any manner through current or future available technologies.



• Failure to comply with any of the terms under the License section will be considered a material breach of this Agreement.

2. SCOPE OF LICENSE

The software is licensed, not sold. Block Zero reserves all other rights. Unless applicable law gives you more rights despite this limitation, you will not (and have no right to):

- 1. work around any technical limitations in the software that only allow you to use it in certain ways;
- 2. reverse engineer, decompile, or disassemble the software;
- 3. remove, minimize, block, or modify any notices of Block Zero or its suppliers in the software;
- 4. use the software in any way that is against the law or to create or propagate malware; or
- 5. share, publish, or lend the software (except for any distributable code, subject to the terms above), provide the software as a stand-alone hosted solution for others to use, or transfer the software or this agreement to any third party.

3. INSTALLATION AND USE RIGHTS.

- 1. **General.** You may install executables and libraries according to instructions and use the application through the intended interface.
- Included Block Zero Software. The software may include other Block Zero softwares or libraries.
 These license terms apply to those included softwares, if any, unless other license terms are provided with the other Block Zero softwares.
- 3. **Third-Party Applications.** The software may include third-party applications that Block Zero, not the third party, licenses to you under this agreement. Any included notices for third-party applications are for your information only.

4. DATA

The software collect information about the use of the software and send that to the Vendor. The Vendor may use this information to provide services and improve its products and services. The data collected is



anonymised and only provide usage and context information. Your opt-out rights, if any, are described in the product documentation.

5. EXPORT RESTRICTIONS

You must comply with all domestic and international export laws and regulations that apply to the software, which include restrictions on destinations, end users, and end-use.

6. SUPPORT SERVICES

Block Zero is not obligated under this agreement to provide any support services for the software. Any support provided is "as is", "with all faults", and without warranty of any kind.

7. UPDATES

The software may periodically update.. You may obtain updates only from Block Zero or authorized sources. Block Zero may need to update your system to provide you with updates. You agree to receive these automatic updates without any additional notice. Updates may not include or support all existing software features, services, or peripheral devices.

8. LIMITATIONS OF LIABILITY

- The Software is provided by the Vendor and accepted by the Licensee "as is". The Vendor will not be

- 3. The Vendor does not warrant that use of the Software will be uninterrupted or error-free. The Licensee accepts that software in general is prone to bugs and flaws within an acceptable level as determined in the industry.



9. TERMINATION

This Agreement will be terminated, and the License forfeited where the Licensee has failed to comply
with any of the terms of this Agreement or is in breach of this Agreement. On termination of this
Agreement for any reason, the Licensee will promptly destroy the Software or return the Software to
the Vendor.

10. MISCELLANEOUS

- 1. This Agreement can only be modified in writing and signed by both the Vendor and the Licensee.
- 2. This Agreement does not create or imply any relationship in agency or partnership between the Vendor and the Licensee.
- 3. Headings are inserted for the convenience of the parties only and are not to be considered when interpreting this Agreement. Words in the singular mean and include the plural and vice versa. Words in the masculine gender include the feminine gender and vice versa. Words in the neuter gender include the masculine gender and the feminine gender and vice versa.

Representations which may have been made by any party to this Agreement may in some way be inconsistent with this final written Agreement.
